The meeting was called to order by Sheriff Julian C. Whittington.

Assistant Chief David Miller made a motion to forego the reading of the minutes of the last meeting and accept as presented. The motion was seconded by Major Doyle Dempsey. The motion carried unanimously.

There being no old business to discuss, Michele Cooksey then presented the millage renewal resolution to adopt the millage rate of **14.10** on all taxable property shown of the official assessment roll for the year, **2023**. Said millage rate(s) are:

TOTAL MILLS	<b>14.10 Mills</b>	



Sheriff Julian C. Whittington, present and being the only voting member, voted **Yea** to adopt the resolution.


